## Meet the Panel



**Dr. Ryan Lee-James** is an ASHA-certified speech-language pathologist and published author with expertise in language development, language disorders, and literacy in the context of linguistic differences and socioeconomic disadvantage.

In her current role as the Chief Academic office of the Atlanta Speech School and Director of the Rollins Center for Language and Literacy, Lee-James is responsible for working collaboratively across organizations and key stakeholders to impact language and literacy achievement for each child at the School and every child. Before joining the team at the Atlanta Speech School, Lee-James trained and mentored graduate level speech-language pathologists as a member of the Communication Sciences and Disorders faculty at Adelphi University in New York. Lee-James holds a B.A. in Communication Sciences and Disorders from Michigan State University, an M.S. in Speech Pathology from West Virginia University, and earned her Ph.D. from Georgia State University.



**Tina Engberg** is the State Leader for Decoding Dyslexia Georgia, which has lobbied the GA Legislature extensively to advocate for:

- A universal definition and understanding of "dyslexia" in the state education code
- Mandatory teacher training on dyslexia, its warning signs and appropriate intervention strategies
- Mandatory early screening tests for dyslexia
- Mandatory dyslexia remediation programs, which can be accessed by both general and special education populations
- Access to appropriate "assistive technologies" in the public school setting for students with dyslexia

SB48 was signed into law by Governor Kemp in 2019. This bill is a start in the right direction in identifying students at risk for dyslexia.

Tina participated in the creation of Georgia's Dyslexia Handbook, providing necessary feedback as a part of a collaborative effort to produce the document which is the state's official guidance to school districts. She successfully led an effort to have the Georgia Legislature fund SB48, 2019 (\$1.6 Million) in Georgia's 2022 Fiscal Year budget for screening and to fund a position for a Dyslexia specialist at the Department of Education. Her team of incredible dedicated parents across the state created relationships with the State Board of Education to bring awareness to Dyslexia and related reading instruction issues to the State Board. She graduated with a B.A. from Bates College and will begin a Masters in Reading Science at Mt. St. Joseph in August.

She aims to use structured literacy to positively impact every child. **Dr. Robin McClellan** has served Tennessee teachers and students for twenty-six years as an elementary teacher, principal, and Supervisor of Elementary Curriculum and Instruction. During her tenure as an elementary supervisor in Sullivan County, Robin spearheaded the implementation of high-quality instructional materials (HQIM) across the district's eleven elementary schools, which she considers the greatest learning and leadership journey of her career. She also served as a reviewer for Rivet's Professional Learning Partner Guide.

Robin served as Assistant Commissioner of Academics and Instructional Strategy at the Tennessee Department of Education, where she managed the state's nationally recognized Early Reading Training program, which provided over 10,000 teachers and leaders with curriculum-based professional learning (CBPL) grounded in HQIM.
